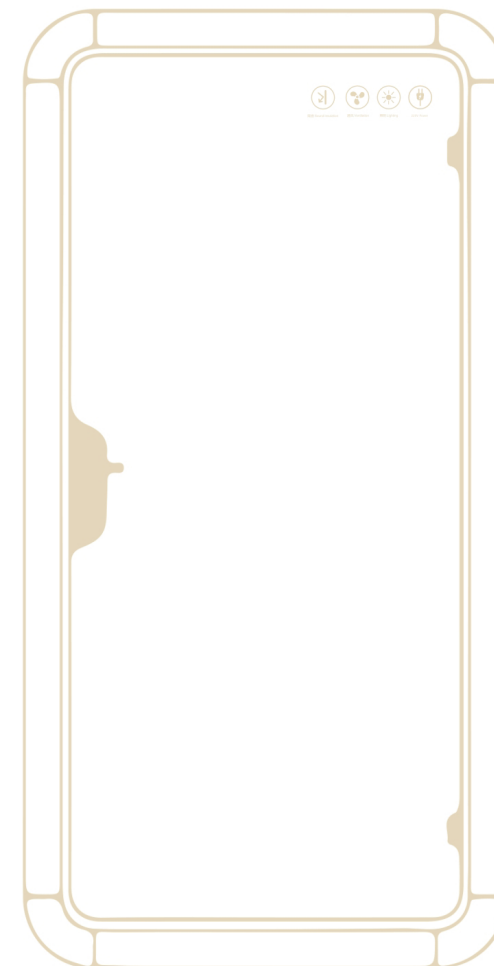

一、本產品享有一年期免費質保和終身維修服務。質保條件是基於產品材質不良或設計缺陷造成的損害。

三、超出質保期限產品部件維修或更換，需收取相應成本費用。

- 6、二次組裝或運輸不當所造成的產品損壞；

7、自然災害（雷擊、地震、海嘯等）和意外情況等不可抗力；

TERMS OF WARRANTY

1. The Soundbox Silence Booth is covered for a one-year-warranty. If you consider that the product which you purchased is of poor product quality or has design defects, you can make a claim under this warranty.
2. The period during which this warranty is in effect will depend upon the Silence Booth to which it relates. In all cases the commencement date for this period is the actual date of purchase, as reflected on the invoice/receipt provided to you.

3. The Soundbox Silence Booth is a modular product manufactured with standard moulds; therefore, you will not need to send back the product. Instead, you can disassemble the defective parts and replace it with a new one.

4. If the time of problem found exceeds this period of warranty, you will need to cover the related cost.

5. Product damage(s) caused by the following factors are not included in this warranty

- a. Incorrect connection to the power supply or the voltage not matching as instructed.
- b. Improper use or not following the instructions for use and assembling.
- c. The working environment does not meet the applicable conditions for the design of this product.
- d. Damage to the glass or finishing surfaces after product acceptance.
- e. The ventilation system or the refrigeration system is in lack of necessary maintenance for dust removal.
- f. Product damage caused by transportation or improper assembly.
