AMENDMENT NO. 3 TO MASTER MA147, MN CONTRACT No. 141112, CONTRACT RELEASE No. F-379(5)

THIS AMENDMENT is by and between the State of Minnesota, acting through its Commissioner of Administration ("State"), in cooperation with NASPO ValuePoint and Steelcase, Inc., 901 44th Street, Grand Rapids, MI 49508 ("Contractor").

WHEREAS, the State has a Contract with the Contractor identified as Contract No. 141112, August 22, 2018, through January 21, 2023 ("Contract"), to provide Furniture: Seating, Systems, Office and Related Services; and

WHEREAS, Minn. Stat. § 16C.03, subd. 5, affords the Commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

WHEREAS, the terms of the Contract allow the State to amend the Contract as specified herein, upon the mutual agreement of the Office of State Procurement and the Contractor in a fully executed amendment to the Contract.

NOW, THEREFORE, it is agreed by the parties to amend the Contract as follows:
