

## STATE OF UTAH COOPERATIVE CONTRACT AMENDMENT

TO BE ATTACHED AND MADE PART OF the specified contract by and between the State of Utah Division of Purchasing and Steelcase Inc. (Referred to as CONTRACTOR) and Midwest Commercial Interiors (Authorized Dealer).

## BOTH PARTIES AGREE TO AMEND THE CONTRACT AS FOLLOWS:

The Participating Addendum Section 3 Design, Installation and Reconfiguration Services is deleted and hereby replaced with the following language for Services provided by Midwest Commercial Interiors only. For clarity, the following language shall not apply to any other Authorized Dealer: Contractor shall provide, through their Authorized Dealer network, all design, installation, layout, and reconfiguration services to all Purchasing Entities.

- Design and layout services will be charged on an hourly basis; the maximum charge for these services will not exceed \$58.00 per hour.
- Order specification services for new products, reconfiguration of existing products, or a mix of new and existing products will be charged on an hourly basis; the range for these services during business hours is \$40.00 to \$48.00 per hour and the range for these services after business hours is \$60.00 to \$72.00 per hour.
- Installation charges for all products offered through this PA will be charged on an hourly basis; the range for these services during business hours is \$48.00 to \$55.00 per hour and the range for these services after hours is \$72.00 to \$82.00 per hour.
- Business hours is defined as 7:30 AM to 5:00 PM.
- As an alternative to hourly rates, Purchasing Entities can elect to have the total costs for delivery and installation be calculated based on a range of 5% to 7% of the total manufacturer product list price prior to the percentage discount being applied (depending on the complexity and geography of the project). This percentage rate will be listed as a separate line item.

All other terms and conditions of the contract, including those previously modified, shall remain in full force and effect.
