






Tap the button on the side of the Tracker to turn it on and off (the Purifier's button doesn't effect the Tracker):



#### Use Auto mode


Tap the Auto button on the Purifier to turn on Auto mode:




Auto mode automatically adjusts the airflow level based on the air quality (as sensed by the Tracker).

1. Snap the kickstand into Wynd's attachment points.




2. Expand the kickstand to funnel clean air at an angle.



## Charge Wynd




Plug in the supplied USB-C cable to the slot in the back of Wynd.




To charge the Tracker, dock it in the Purifier and turn on the Purifier,

## Change the filter


1. Screw off the bottom cap.

The filter should last an average of 3 months, and the app provides the filter lifetime. Order more through the app or at hellowynd.com.


## Purifier or Tracker not working right?
